



Other Fees 2023

Training and Certification Fee: To give real life exposure to students and to make them industry ready professionals, shortduration industrial tours/training and/or online trainings shall be organized for all students of full-time programs,

The trainings may lead to certification in all programs Except for Engineering PG, Law PG and BA (Public Policy), B.Com / B.Sc. & Pharma students where it will be a credited course. A charge of Rs. 26,500/- (one time) is to be paid in 5thsemester incase of UG Programs and 2nd semester in case of PG student. In case travel of industrial tour by air is necessitated, additional charges, if any, would be intimated to the students concerned for payment prior to commencement of the tour. For BBA Students they must pay this amount along with 3rd Semester fee.

Personality Development Courses (PDC) Fee: To improve communication and soft skills and placement selection chances, it is mandatory for all the students (Except B. Com / B.Sc.) to attend the Personality Development Program organized by UPES. PDP fee of Rs.7500 /- for PG shall be payable at time of registration. PDP fee for UG programs is Rs.20,000/-, out of which half is payable at the time of admission and balance half in penultimate (second last) semester.

Refundable Security: Refundable (interest free) security amount of Rs.20, 000/- is also payable at the time of registration.

Levies and Taxes: In case any taxes/ levies on fee are charged by the Central/State/Local Authorities/Overseas Authorities from time to time, the same shall also be borne by the students.

1. Who will get Scholarship?

All students who have applied for admission for UPES courses and have taken UPES entrance examination shall be eligible for consideration for this scholarship. However, this Scholarship shall be awarded only to those students who has complied with below defined Scholarship Criteria for first semester and subsequent renewal, if applicable.

2. Scholarship Criteria

Scholarship will be awarded **upto** 10% Top performers of UPES Entrance Exam. UPES reserves the right to conduct multiple rounds of entrance examination and merit list of each round will be prepared separately. However, it is UPES sole discretion, to decide consideration of next in line of top 10 for said Scholarship, in case top performer does not accept the scholarship for any reason.

3. Total number of scholarships

Total number of scholarships available are up to 1900 (out of these 50% will be reserved for girls i.e., 950 scholarships and balance is for general category including boys and girls both).

4. Scholarship Benefits

Scholarship will be awarded in range from 20% to 100% on tuition fees of 1st semester only. Renewal of scholarships for rest of the semesters is at the sole discretion of UPES.

5. Scholarship Renewal Criteria

Continuation of Scholarship in the subsequent semesters will be as per the University policy which may differ year on year basis. However, it will be subject to meeting of minimum eligibility criteria as below:

- 1) Minimum SGPA/CGPA of 8.5 in each semester.
- 2) Passed every semester at first try without any supplementary or improvement exam.
- 3) Maintenance of 75% attendance in entire semester
- 4) No disciplinary action initiated/ awarded against the student
- 5) Exemplary behavior and compliance with all other norms as prescribed by the University from time to time
- 6) If student fails to score minimum of 8.5 SGPA in any semester, the scholarship will not be renewed
- 7) Scholarship will be awarded in form of Fee Concession; Fee Discount; Fee Waiver on tuition fees only. The decision of percentage of the Fee Concession; Fee Discount; Fee Waiver on Tuition fees shall be the sole discretion of UPES.
- 8) It is the responsibility of the applicants to check their eligibility before submitting their applications. In case the applicant is found non-eligible at any stage, his/her submission or scholarship will be disqualified.
- 9) Decision of the Scholarship Committee shall be final applicants and cannot be challenged.
- 10) The Result shall be communicated to all shortlisted applicant though Email/SMS.
- 11) UPES reserves the right to withdraw or amend any listed scholarship without prior notification and at any point in time at its sole discretion.
- 12) If scholarship selected student chooses to decline the course offer, said students' scholarship shall be void.
- 13) The Scholarship amount will be adjusted against student fees. Awarded scholarships can't be exchanged for cash/cheque or transferred to any other course or campus or academic year/semester etc.

STUDENT FINANCIAL SUPPORT

The University has extended a financial support to the students who are unable to pay the tuition fee on account of having lost any of the earning parents AFTER TAKING ADDMSISSON AT UPES AND AFTER SUBMITTING FULL FEES FOR ATLEAST ONE SEMESTER

Amount Given as Support:

• The financial support extended by the University is a relaxation of Rs 50,000/- towards their tuition fee per semester till the last qualifying semester.

Eligibility Criteria:

- The student should maintain / improve their academic performance every semester.
- The students applying for relaxation should not have any NC (Not Clear) or Backlog in any semester. However, the scholarship committee can use its discretion can recommend the Vice Chancellor for approval without using this as a precedent for future cases of the same nature if any.
- He/ She should also have a clear record on discipline background.
- This relaxation is applicable only for the upcoming semester.

Applicable Conditions:

- The above relaxation is only for one semester.
- Students desirous for the extension in next semester will be required to submit fresh application along with the grade card of last exam passed once a communication is circulated by the department of Student Engagement and Experience.
- The Committee reserves the final right to approve an application received from the students.

Mandatory Requirements

It is mandatory for all students seeking admission to provide below documents.

- 1. Aadhar Card Number at the time of Registration
- 2. Permanent Account Number (PAN-All students and Parent)
- Student academic record/personal record will be verified at the time of admission through the original documents. Student will only submit the self-attested copy of required document for admission. Studentsare not supposed to submit any original document.

Hostel Facility

Residential blocks have been earmarked for limited on – campus accommodation (on first come first serve basis) separately for boys and girls on triple sharing basis. Students wishing to avail hostel facility (On-campus)will need to deposit fee in advance.

The fee indicated below is for academic session 2022-23 only and is on triple sharing basis

Reservation of Seats

These seats will get allotted based on the merit order in this category, provided the candidate has declared his intent to opt under this category at the time of applying for admission.

Placement

Commencement of actual classes begins from the date of commencement of PEP (Personality EnhancementProgram) held immediately after registration.

Admission Process for International Students

A student holding an Indian passport but having qualified higher secondary examination/undergraduate degree or equivalent from a foreign country will be classified as international and apply as international student.
